## **RYERSS FARM ADMITTANCE & WAITING LIST POLICY**

Horse's Name: \_\_\_\_\_

1. There is a non-refundable application fee of \$100 to help defray administrative expenses. This \$100 will be deducted from the admittance fee when your horse retires to Ryerss Farm.
2. A horse may be placed on Ryerss Farm's Waiting List at any age, but will not be offered a place until the horse is at least 20 years old.
3. When the offer of a stall is made to a horse's owner, Ryerss would like to have a decision within a week. If the offer is accepted, Ryerss would like to have the horse retired within a month.
4. A horse's retirement to Ryerss may be deferred for a period of one, two or three years for up to two times. Additional deferrals will require a non-refundable fee of \$100 each.
5. If two or more horses need to be brought in together, a fee of \$450 will be assessed monthly for each stall that is being held empty for these horses until the required number of empty stalls becomes available.
6. At least 30 days before being admitted to Ryerss, all horses should have their shoes removed, unless they are needed for medical reasons and the owner is willing to accept the financial responsibility.
7. At the time of admittance to Ryerss Farm, the horse's ownership is transferred to Ryerss Farm. Ryerss becomes the sole owner and care provider. The former owner relinquishes all rights to said horse and the horse shall remain at Ryerss Farm until it expires. There is a one-time admittance fee for retiring a horse to Ryerss. The amount is reviewed annually and posted on the web site.
8. Prior to final acceptance as a permanent resident of Ryerss Farm, each incoming horse will be subject to an agreed 60 day Mutual Trial Period between its owner and Ryerss Farm.
9. Upon admittance, former owners are expected to cover, on a monthly basis, the cost of shoes (if required) and the cost of any medications needed for their horses. Should a horse's overall health condition change, former owners may be asked to help with additional medications.
10. Because of stall size, a horse 15hh or less will be offered a place in the upper barn when it becomes available. A horse over 15hh will be offered a place in the main barn when it becomes available. However, if two or more horses coming in together are of different sizes, which would result in splitting them up, they will be given stalls in the main barn together.
11. If a horse is accepted as a "rescue" from an animal sanctuary or similar authority, Ryerss Farm will make every effort to accommodate said horse/horses with or without the entrance fee and the age requirement may be waived.
