RYERSS FARM FOR AGED EQUINES

Planned gifts to Ryerss Farm can be made, by example, in one or more of the following ways:

- A Bequest in the form of a percentage of an estate, a specific dollar amount, or a specific asset such as real estate or tangible personal property. Bequests are the most common way to make a donation to Ryerss Farm through your estate.
- A Gift of a Qualified Retirement Plan, such as an IRA or the stock or proceeds of a 401k plan.
- A Gift of Real Estate.

Here is sample language that you could share with your attorney for his/her consideration in drafting a bequest in your will or trust:

Specific Gift Language (Naming Ryerss Farm as a beneficiary of a specific amount from your estate)

I bequeath to Ryerss Farm for Aged Equines, 1710 Ridge Road, Pottstown, PA 19465, the sum of \$_____ (or asset).

Residual Gift Language (A residual bequest comes to Ryerss Farm after your estate expenses and specific bequests are paid)

I bequeath to Ryerss Farm for Aged Equines, 1710 Ridge Road, Pottstown, PA 19465, all (or state a certain percentage) of the rest, residue, and remainder of my estate, both real and personal.

If you have already included Ryerss Farm for Aged Equines in your plans, we thank you so much, and would be honored to include you as a member of the Ryerss Farm for Aged Equines Legacy Society. You always have the right to be included as an "anonymous" member, if that is your preference.

Your planned gift to Ryerss Farm is gratefully received and acknowledged through the Legacy Society and provides a permanent source of support to Ryerss Farm for Aged Equines.
