

RYERSS FARM ADMITTANCE & WAIT LIST POLICY

Equine's Name: _____

- There is a non-refundable Wait List Application fee of \$250.00 to help defray administrative expenses.
- An equine may be placed on the Ryerss Farm Wait List at any age, but will not be offered a stall until the equine is at least 20 years old.
- When the offer of a stall is made to an equine's owner, Ryerss Farm requests a decision of acceptance or refusal within 30 days. If the offer is accepted, our Requirement at Time of Admission form will be given to the owner. At least 30 days prior to entering Ryerss Farm, all equines should have their shoes removed, unless required for medical reasons. A donation to the cost of shoeing will be appreciated.
- Ryerss Farm would like to have the equine brought to our facility within 45 days, but if the equine does not arrive within 45 days there will be a \$450.00 per month charge to keep the stall available.
- At the time of admittance to Ryerss Farm, the equine's ownership is transferred to Ryerss Farm, thus Ryerss Farm becomes the sole owner and care provider. The former owner relinquishes all rights to said equine and the equine shall remain at Ryerss Farm until it expires.
- There is a one-time Entrance Fee for retiring an equine to Ryerss Farm For Aged Equines. The amount is reviewed annually and posted on the website. The Entrance Fee is not tax deductible. Anything over the current fee amount can be considered as a donation.
- Prior to final acceptance as a permanent resident of Ryerss Farm, each incoming equine is subject to a 30 day mutual probation period between its owner and Ryerss Farm, called Ryerss Farm Remorse Agreement.
- Upon admittance, former owners are expected to cover the cost of any non-medically prescribed supplements the owner wishes to provide for the equine at their expense, until said equine expires. A donation to the cost of any veterinarian prescribed medications required for preexisting conditions will be appreciated.
